Catalyzing Transfer Initiative



Over the last decade, major transfer efforts have focused on impacting articulation policies and improving student experiences, but barriers impacting transfer students persist while racial equity gaps have widened. Research shows that transfer enrollment and completion declines disproportionally affect students from low-income backgrounds and Black, Latinx and Indigenous students. Inconsistent policies and practices at the institutional and state level lead to students taking excess credits, spending more time and money, and losing their sense of belonging on campus. ECMC Foundation launched the Catalyzing Transfer Initiative (CTI) to achieve more equitable outcomes for today's community college students who seek to complete a bachelor's degree.



Research shows 80% of students enrolled in public twoyear institutions aim to earn a bachelor's degree. But, only 15% of students who start at community college earn a bachelor's degree within six years.




Students lose 43% of credits upon transferring, on average.

At this rate, of the more than 4.5 million students enrolled in public community college in Spring 2021, fewer than 800,000 will earn a bachelor's degree.*

The Western Interstate Commission on Higher Education is expanding the number of institutions enrolled into the Interstate Passport® Network, a national network of institutions and states that agree to accept transfer of lower-division general education attainment as a block (Passports) based on student learning outcomes.

Transfer BOOST

The Institute for Higher Education Policy is supporting institutions and state partners in Arizona, Illinois and Virginia in creating Transfer Affordability Guarantees (TAGs) in partnership with HCM Strategists. TAGs are equitycentered pathways that ensure students can complete a bachelor's degree in a timely manner by supporting students through a mapped pathway, guaranteeing that all credits apply to completion, and clearly defining and communicating cost and time-to-degree.
